UTILITY SERVICES & OTHER VILLAGE INFORMATION

Welcome to the Village! Whether you are new to the area, or returning after an absence, here are some updates.

Quarterly billing occurs for Water and/or garbage service in March, June, September & December. The due date is 30 days after billing; after 30 days, 10% penalty on unpaid, and 2% monthly thereafter until paid. **

Solid Waste (garbage) service is currently \$63.50 per quarter, \$53.50 for seniors 65+. Service allows up to two (2) 32-gallon (maximum) garbage cans per week. Bags must be clear plastic & garbage must be placed at the curb by 6:00 AM on Mondays. If you have more than two garbage cans, you may purchase an excess garbage tag for \$3.50 at the Village Office for each additional can needed. Tags can be purchased for large items that do not fit a garbage can as well, for \$5.00/\$10.00 each, depending on the size of the item. A resident must be on the garbage service in order to use the tags. There is also electronic/appliance tag system open to all residents. Contact the Village office to sign up for garbage service. If you are a tenant and your landlord does not offer garbage service, we do offer the option of opening an account in your name, payable within 30 days of billing; if service is unpaid after 30 days, garbage services would be terminated; as the tenant can request to have service re-instated but will need to pay ahead for service at time of request.

RECYCLABLES ARE NOT COLLECTED BY THE VILLAGE- Collection by Taylor Garbage weekly on Fridays; if you have an issue with your recyclables contact Taylor at 607-687-6710.

Regarding water billing, properties have electronic water meters and are read by the Dept. of Public Works 15 days before quarterly bills are prepared. All properties incur a minimum usage, capital charge and debt service charge. If you need further explanation of your bill please stop by the office during regular business hours and we can answer any questions you may have.

** Any unpaid Solid Waste (garbage) or Water amounts left unpaid at mid-February will be levied onto the Village Tax Bill, which is mailed annually on March 1st.

There is a Newark Valley Annual Clean-Up Day, usually in May, for residents to dispose of their furniture, carpets, misc. household items that wouldn't be placed in regular weekly collection containers, appliances, electronics, etc. The Village also has brush/grass/leaves pickup dates throughout the year April – November, dates are published in the Village newsletter. Leaves are to be in brown leaf bags or in containers that can be dumped; brush needs to be of certain size – contact Dept. of Public Works @ 642-8700 for more details. Also review the Village website and Facebook page for other announcements.

Village Board Meetings are held the second Tuesday and fourth Monday of each month at 6:30PM in the Municipal Building at 9 Park Street, Newark Valley, New York.
