Hi Everyone,

Your Trout Ponds Park Basketball/Skating Rink awaits some consistent cold weather for ice to stabilize. Our Public Works team is keeping the snow off the rink to be ready for skating season. Many youths and adults are excited and expect a number of Hockey Matches and free skating experiences. This 2023 financial expansion of your Trout Ponds Park is due to Trustees, Mayor, and Staff. Trustee Joseph Mooney, Clerk Pam Benthin and Supervisor of Public Works Matt Seamans logged many personal and public hours of talent, sweat equity and guidance to accomplish this success. Your Village Government Team does and will continue to seek funding opportunities to vitalize and improve the infrastructure of this quaint community that we all call "home".

Your Village recently purchased an AED (Automated External Defibrillator) and installation will be complete after proper equipment training. This mechanism is used to help those experiencing sudden cardiac arrest. The medical device will analyze the heart and, if necessary, deliver an electrical defibrillation helping the heart re-establish effective rhythm. The mechanism will be efficiently stationed in proximity to staff. Village tenant Maine Emergency Squad, Inc. will administer the training.

I believe you are all aware of Tioga Opportunities, Inc. and their wonderful helping hand and assistance throughout our Southern Tier. Home Delivered Meals, Congregate Dining, Nutritional Counseling, Women/Infants & Children (WIC), Family Health Service, Transportation, Medicare Counseling, Energy/Weatherization, Radon Testing, Rental Assistance and many other offerings to our friends and neighbors. TOI outreach to Newark Valley Community Connection. Health Center, 2nd Wednesday every month from 1PM to 4PM.

#### **CLERKS OFFICE:**

Happy February everyone. We are one month closer to SPRING! The sunshine has been so nice the past few days! Let's hope it continues!

March not only is the beginning of spring, but it is also the beginning of the Village's fiscal year. The new year's budget has been passed with a 2.3% increase.

This is approximately a \$.28 per thousand increase. What does this mean to you? If your house is assessed for \$85,000 your tax bill will increase approximately \$23.80.

Tax bills will go out March 1st with payments will be due by March 31st with no penalty, payments are accepted through October 31st penalties applied. Payments can be made inperson at the Village office (located at the rear entrance of 9 Park St.) placed in the drop box located at the Village office entrance, mailed, or paid on-line. Please note, if you plan to pay online our credit card processor AllPaid, does charge a processing fee. This is not a Village fee. The link to make an online payment can be found on our webpage under the online payments tab. We also offer a direct debit option from your bank account each billing month. This service is free of charge, if you are interested, please contact the office for an application.

The Village will be holding its regular election on Tuesday, March 19<sup>th</sup> in the Municipal Building Noble room, 9 Park St. Polls will be open from Noon until 9:00 PM. There are two Trustee positions on the ballot this year. There are three candidates running for these positions. Jackie Wandell, Kenneth Giblin and James Phillips.

The Village recently received our annual CPA audit report. We received a good report with no findings. As always, we will continue to strive for no findings in our next audit.

As you may know, the Village contracts its recycling collection with Taylor Garbage. Recently, Taylor Garbage has increased their fees for recycling collection, which means that we need to increase our quarterly recycling fee by \$1.50. The new quarterly recycling charge will be \$23.76. The recycling portion of your quarterly bill is the only portion that will be increased.

Unfortunately, the time has come for Jess, our Deputy Clerk Treasurer, and her family to move

south. While we are sad to see her go, we are happy that Jess is fulfilling her dream of getting away from the snow and cold and moving to a warmer climate. We would like to thank Jess for more than six years of dedicated service to the Village. Jess has been a huge asset to the Village. She has made countless contributions to the Village; her most recent contribution is successfully obtaining funding for our Trout Ponds summer entertainment series! Stay tuned for more information coming soon! Thank you, Jess! I will miss Jess both personally and professionally. #### **PUBLIC WORKS DEPARTMENT:**

The DPW has been very busy, as of late, repairing some leaks to water mains here in the village. Both leaks were found and repaired in a timely manner. A huge thank you to those residents on Smullen & Cook, your patience with us while we repaired those leaks is very much appreciated. We would also like to thank the Town of Newark Valley for their assistance with both equipment and manpower.

The ice rink is up at our beloved Trout Ponds. Mother nature, and the lack of ice rink maintenance knowledge have yet to make it worthy of skating on. We have installed signs that state that the ice is not safe, but they seem to be ignored. This extra foot traffic on the ice will only delay us in preparing the rink's surface for skating. There will be a rules sign installed, along with green or red flags to notify the public of safe or unsafe ice conditions.

Just a reminder that Village parking laws are still in effect until April 1st. Per <u>Chapter 157. Vehicles and Traffic - Article III & VI. Parking, Standing and Stopping & Schedules</u> - No person shall park a vehicle between the hours of midnight and 6:00am of any day, in the parking lot of the Municipal Building, on any highway (St. Rt. 38/Main St.), or on any private road (village streets), within the corporate limits of the Village.

Also, we are still in the time of year when sidewalks and drains need to be kept clear of snow. Per *Chapter* 140. Streets and Sidewalks Article V. Removal of Snow and Ice - From October 1 of each year until April 15 of the following year snow and ice shall be removed within 24 hours after the end of a snowfall on residential sidewalks. Sidewalks in front of commercial establishments and commercial parking lots shall be kept free of snow and ice at all times between the hours of 9:00 a.m. and 5:00 p.m. Failure to remove ice and snow within the time period shall be deemed to be a public emergency, thus allowing the Village DPW to remove any snow and ice present at the expense of the property owner. If you have a fire hydrant on your property, it's always a good idea to clear access around them, if you are able. The DPW will clear them routinely, but hydrants are last on the list in the snow removal procedure.





lasting bonds. We are filled with gratitude for the unwavering support we have received during the incredible journey of the past 6 months developing Newark Valley Community Connection. In a short time, we've accomplished so much together! From the monthly lunches to the dinners, concerts, and the heartwarming family and children's holiday celebrations, we've witnessed the transformative power of community connection. We especially would also like to thank the generosity of the members of the old Congregational / United Church of Christ for their decision to donate their buildings so that we could create such a wonderful and historic place to gather.

We always need and appreciate volunteers and also want to hear your ideas! In between these upcoming events listed below, we will be working hard to create inviting spaces for family movie watching and youth activities.

The lower levels of the buildings have plenty of room for creative uses, such as creating a Maker Space Workshop. We will be meeting with the Youth Rotary Interact Club so we can hear ideas from our local area youth about what they would like to see in the community building. Ideas have ranged from setting up a podcast area, to pool tables and maker spaces thus far. A generous grant of \$8,875 from the Floyd "Vic" Hooker Youth Fund of the Community Foundation for the Twin Tiers will serve as the foundation for creating engaging movie times, family programs and establishing a safe space for our youth at Newark Valley Community Connection.

Recognizing the importance of family well-being, we are excited to soon establish an indoor children's play space (not for drop ins but for children with caregivers' present), creating opportunities for parallel play and early childhood development. The community buildings will also serve as a satellite location for a family health clinic, ensuring accessible healthcare and family planning resources for residents.

Here's a glimpse of what's coming up, with more events to be added: These events are donation based but play a crucial role in raising funds for operating expenses (utilities and insurance are over \$15,000 per year!), more improvements and community initiatives. #### INTRODUCTION

To comply with State regulations, Village Newark of Valley will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

#### WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Departments and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves over 1000 people through about 416 service connections. Our water source is 2 ground water wells. Well # 3 is located on Whig Street adjacent to the village barn and is about 120 feet down, well # 4 is located at the Trout Pond Park and has a depth of 150 feet. The water is treated with sodium hypochlorite solution to a minimum of 0.2 and a maximum of 4.0 ppm as a disinfectant prior to distribution and is stored in an aboveground concrete reservoir which provides 500,000 gallons of finished water for distribution.

Our source water's susceptibility to contamination is very minor because our one source aquifer is slow moving, and our wells are at a sufficient depth. Other than horizontal fracking (which is not allowed in New York) we have an in-ground fuel storage tank about 500 feet from the well head, but the tanks are continually monitored for leaks and the vast majority of salt is stored in concrete storage areas. We do not pump water from streams or shallow wells which is more likely for contamination.

#### ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include total coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes, haloacetic acids, radiological and synthetic organic compounds. The table included within this report depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, is more than one year old.

It should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. ### <u>Perfluorooctanoic acid(PFOA), Perfluorooctanesulfonic acid(PFOS), and 1,4 Dioxane(1,4-D)</u>

PFOA, PFOS, and 1,4-D are relativity ubiquitous in the environment due to their historical widespread use persistence. PFOA and PFOS have been used in a variety of consumer and industrial products as surface coatings and/ or protectants because of their nonstick properties. Research further indicates that these compounds bioaccumulate in various organisms, including fish and humans. 1,4-D has been largely used as a solvent stabilizer for chemical processing but can also be found as a purifying agent in the manufacturing of pharmaceuticals as well as a contaminant in ethoxylated surfactants commonly used in consumer cosmetics, detergents, and shampoos. Research indicates that this chemical does not bioaccumulate in the food chain. We are happy to inform you that our testing shows we have no violations and did not exceed the MCL set forth by the Health Department.

#### **LEAD**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community because of materials used in your home's plumbing. The Village of Newark Valley is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. This level represents the highest locational running annual average calculated from data collected.

<sup>2 –</sup> The level presented represents the 90th percentile of the 10 sites tested. A percentile is a value on a scale of 100 that indicates the percent of a distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the copper values detected at your water system. In this case, ten samples were collected at your water system and the 90th percentile value was the <0.0050 value the action level for copper was not exceeded at any of the sites tested. All residents that participated in the lead and copper test were delivered a test result for their house to keep them informed.

#### **Definitions:**

- <u>Maximum Contaminant Level (MCL)</u>: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible.
- <u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- <u>Maximum Residual Disinfectant Level (MRDL)</u>: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- <u>Maximum Residual Disinfectant Level Goal (MRDLG)</u>: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.
- <u>Action Level (AL)</u>: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- <u>Treatment Technique (TT)</u>: A required process intended to reduce the level of a contaminant in drinking water.
- <u>Level 1 Assessment:</u> A Level 1 assessment is an evaluation of the water system to identify potential problems and determine, if possible, why total coliform bacteria have been found in our water system.
- Level 2 Assessment: A Level 2 assessment is an evaluation of the water system to identify potential problems and determine, if possible, why an *E. coli* MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
- Non-Detects (ND): Laboratory analysis indicates that the constituent is not present.
- *Milligrams per liter (mg/l)*: Corresponds to one part of liquid in one million parts of liquid (parts per million ppm).
- *Micrograms per liter (ug/l)*: Corresponds to one part of liquid in one billion parts of liquid (parts per billion ppb).
- *Nanograms per liter (ng/l)*: Corresponds to one part of liquid to one trillion parts of liquid (parts per trillion ppt).
- <u>Picograms per liter (pg/l)</u>: Corresponds to one part per of liquid to one quadrillion parts of liquid (parts per quadrillion ppq).
- *Picocuries per liter (pCi/L)*: A measure of the radioactivity in water.
- *Millirems per year (mrem/yr)*: A measure of radiation absorbed by the body.
- Million Fibers per Liter (MFL): A measure of the presence of asbestos fibers that are longer than 10 micrometers.

#### WHAT DOES THIS INFORMATION MEAN?

As you can see from the above table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below the level allowed by New York State.

### IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

During 2023, our system was in compliance with applicable State drinking water operating, monitoring and reporting requirements.

#### DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Although our drinking water met or exceeded state and federal regulations, some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer, undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. #### WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are several reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life.
- ◆ Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers; and
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential firefighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- ♦ Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded. So, get a run for your money and load it to capacity.
- Turn off the tap when brushing your teeth.
- ♦ Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it and you can save almost 6,000 gallons per year.
- ♦ Check your toilets for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

#### **CLOSING**

Thank you for allowing us to continue to provide your family with quality drinking water this year. To maintain a safe and dependable water supply we have made new and costly improvements over the last eight years that will benefit all our customers. We ask that all our customers help us protect our water sources, which are the heart of our community.
